

PINE TREE ZONE CREDIT APPLICATION

The applicant, whose name appears below (the "Customer") hereby makes application to Emera Maine for the purpose of obtaining electric transmission and distribution service ("Delivery Service") from Emera Maine pursuant to terms of Emera Maine's Pine Tree Zone Credit Tariff (the "Tariff"), which is incorporated by reference and made a part of this application. If this application is accepted by Emera Maine, Emera Maine shall acknowledge its acceptance in writing, either by letter or electronic mail. This application, together with the Tariff, shall constitute the sole and only contract between Customer and Emera Maine for Delivery Service under the Tariff.

In submitting this application, Customer certifies to Emera Maine:

3. Customer is or will receive Delivery Service at Customer's facilities that are located within a Pine Tree Development Zone at:

(the "Facility" or collectively the "Facilities");
4. Customer has been certified as a Qualified Pine Tree Development Zone Business by the Maine Department of Economic and Community Development (the "DECD"); the date of this certification occurred on: _____ (the "Enrollment Date") (**Customer must include a copy of this certification with this application**);
5. Customer's load for the twelve (12) months preceding the Enrollment Date, divided by four (4) is _____ kWh's.

It is hereby understood and agreed that Emera Maine will provide and Customer will purchase Delivery Service for use at the Customer's Facilities according to the terms of the Tariff. Customer agrees that it is responsible for securing its own electric energy supply. Delivery Service shall be subject to the price and terms of the Tariff and shall commence 30 days following the provision of this application to the MPUC ("Effective Date"). Customer hereby agrees that any Delivery Service provided by Emera Maine and received by Customer for the Facilities prior to the Effective Date shall be at the applicable Emera Maine rate schedule for the Customer and subject to all terms and conditions in effect during that period.

Customer understands that Delivery Service under the Tariff shall terminate on December 31, 2015 at 11:59:59 p.m., unless sooner terminated. Customer expressly agrees that Delivery Service under the Tariff will be automatically terminated if Customer fails to maintain its status as a Qualified Pine Tree Development Zone Business. Customer also agrees that Emera Maine may terminate Delivery Service under this Application pursuant to the Maine Revised Statutes, or the Rules and Regulations of the MPUC. Emera Maine's provision of Delivery Service pursuant to the Tariff is subject to the ongoing regulation of the MPUC and may, from time to time, be modified, superseded or amended by the MPUC. In the event the Tariff is so modified, Customer may, at its sole discretion, terminate its purchase of Delivery Service pursuant to the Tariff and the obligations of the Customer and Emera Maine shall cease and be of no further effect. Either party may terminate Delivery Service under the Tariff in accordance with any statute or MPUC Order or Rules, or any other controlling legal authority. In the event Delivery Service under the Tariff is terminated, Customer hereby agrees Delivery Service will be provided by Emera Maine and received by Customer for the Facilities at the applicable Emera Maine rate schedule for the Customer and subject to all terms and conditions in effect during that period, unless Customer notifies Emera Maine that it wishes to terminate the entire provision of all distribution and transmission service to the Facilities.

Customer hereby applies to Emera Maine for Delivery Service pursuant to the Tariff. All to be rendered in accordance with the terms and conditions above.
