

STREET AND AREA LIGHTING

CHARACTER OF SERVICE

Service under this rate is available for street and area lighting service installations, maintenance and use of energy, and traffic control lighting service provided the customer furnishes the equipment. Customers taking service under this rate schedule are responsible for paying both Distribution Service and Stranded Cost.

RATES

The rate for continuous service shall apply when the facilities are installed for continuous year round use. The rate for periodic service shall apply when the facilities are installed for occasional or periodic service, provided that such service shall not be available for installations where service would be rendered for less than five months per year.

Mercury vapor lighting service is limited to existing installations, and will not be available for new installations after June 1, 2011 (the effective date of the fifty-sixth revision of this tariff previously in effect for Bangor Hydro Electric Company).

Incandescent service, except for traffic control purposes, will not be available after March 31, 1987.

ADDITIONAL CHARGES

For Government Street and Area Lighting only:

Where underground feed circuits or ornamental standards are used, additional charges per unit will be made as follows:

For Ornamental Standards	66.04 per year for the first ten years and 16.52 per year thereafter
For Underground Feed Circuits	33.17 per year for the first ten years and 8.25 per year thereafter
For Both	99.21 per year for the first ten years and 24.77 per year thereafter

For periodic service the above annual additional charges will be prorated over a term of service for each year.

ADDITIONAL CHARGES (CONTINUED)

For installations after November 1, 1986:

For Government Street and Area Lighting only:

Where underground feed circuits or ornamental standards are used, additional charges per unit will be made as follows:

For Ornamental Standards	158.72 per year for 20 years.
For Underground Feed Circuits	264.52 per year for 20 years.
For Both	423.24 per year for 20 years.

For periodic service the above annual additional charges will be prorated over a term of service for each year.

HIGHWAY BRIDGE LIGHTING

For installations of Highway Bridge Lighting where the customer provides and maintains the required duct lines and standards, the Company will furnish the necessary cable and supply service with luminaires adapted as standard by it, at the rates for ordinary installations above. The maintenance of cable will be at the additional expense of the customer and will be billed in accordance with actual costs.

TRANSMISSION SERVICE

The Transmission Service rate shown in this rate schedule is for information purposes only. The Company's Transmission Service rates are subject to the jurisdiction of the Federal Energy Regulatory Commission and are subject to change pursuant to the Company's Open Access Transmission Tariff or other authorized procedure established by the Federal Energy Regulatory Commission.

LATE PAYMENT CHARGE

A late payment charge in accordance with Section 4-F of the Terms and Conditions shall apply to customers taking service under this rate.
